## RULES AND GUIDELINES:

1. On behalf of the Truro Pride Committee, the Parade Marshals are the official on-site authorities. Any instructions given by them must be followed and your courtesy and cooperation is expected. Any entrant not meeting the requirements of participation may be removed from the lineup and subsequent participation may be denied.
2. Animals (horses, dogs, etc.) are permitted. However, if they are walking (not on a float), entrants are required to take care of clean up as necessary.
3. Candies and other giveaways are **not to be thrown** from passing floats. This causes a serious safety hazard and impacts on *everyone's liability insurance*. Instead, please have people walking with your float to hand out these items.
4. Smoking is not permitted in the set up area or during the parade.
5. The Truro Pride Committee reserves the right to screen all entries with an eye to overall impact on the parade and its purpose.
6. All entries must be pre-registered and must have the release waiver signed and submitted to the Downtown Truro Partnership office (on behalf of the Truro Pride

Committee) in order to participate in the parade. Anyone arriving unannounced on parade day may be refused.

7. Town, County and provincial laws and by-laws must be abided by at all times.
8. All individuals/groups submitting parade entries should have liability insurance.
9. All float entries must be safe for passengers and spectators. Please ensure all items are well secured, passengers remain seated and children have adult supervision.
10. All generators must be fully fueled prior to arrival at the set up area to ensure there is no need for refueling during set up or along the parade route.
11. All electrical devices must meet safety standards and electrical output must not exceed the maximum amperage of the generator.
12. All floats must carry a fire extinguisher and a minimum of two handheld flashlights.

**PLEASE NOTE:** ENTRIES ARRIVING LATE MAY BE REFUSED.

## **AGREEMENT: Waiver of Responsibility – Truro Pride Parade/ Exhibitor**

For consideration to participate in the Truro Pride Parade and associated activities to be held July 13, 2019 I, the signer for myself and my group including all successors, agents and representatives do:

1. Agree to abide by all applicable laws and by-laws of the Town of Truro as well as the laws of the County of Colchester and the Province of Nova Scotia.
2. Acknowledge that I fully understand that I will be engaging in activities that involve risk including, but not limited to injury, death, and economic loss.
3. Assume any and all risks to myself, my group and or my/ our property.
4. Agree to indemnify, defend and hold harmless the Downtown Truro Partnership/ Truro Pride Committee, the Town of Truro, Truro Police Service, their officers, agents, employees and volunteers, and all other participants from any and all claims, liabilities, losses and expenses caused by or arising in connection with the Truro Pride Parade.
5. Am aware that the Parade may be photographed, videotaped, or audio taped for publicity, historical, or educational purposes, and that the parade, including video, images and audio from it, may be shared in electronic form on the internet, or in print media, and understand that by participating in the Parade, that I (or my minor child) is likely to appear in materials resulting from the Parade. I hereby grant my consent to the Downtown Truro Partnership/ Truro Pride Committee, in perpetuity, to display the likeness of myself (or my minor child) in any related promotional use without compensation.
6. If driving a motor vehicle in the parade, I declare that I am fully licensed and insured to operate said vehicle in compliance with the Province of Nova Scotia statutes and that I carry liability insurance to cover property damage and personal physical injury to others as a result of operating said vehicle (including appropriate helmet laws)
7. If participating in the parade with an animal, I declare that I will and am able to take total responsibility for any actions of the animal and will not subject the animal to any undue stress or danger.
8. Hereby assume full responsibility for and risk of bodily injury, death, or property damage due to the negligence of those parties listed above while participating in the event.
